Shortly after the subject left the scene, he repeatedly contacted the victim and advised her that he was going to commit suicide. Approximately 3 hours later, the subject arrived at the police department to claim his weapon. At that time, the subject was advised that he was going to be transported for a mental health evaluation. He became irate and subsequently assaulted two police officers before he was subdued. <b>Subject was subsequently charged.</b>
